Recommendations for Council action, SUBJECT TO THE APPROVAL OF THE MAYOR:

1. PRESENT and ADOPT the Ordinance dated December 3, 2013, relative to amending Article 9.5 of the Los Angeles Municipal Code to make various changes to the City's ethics laws.
2. REQUEST the City Attorney to prepare and present a revised Ordinance, substantially in the form as the Ordinance dated December 3, 2013, attached to the Council file, with the following amendment to Sec 49.5.8 (c) (4) b: For all other restricted sources, the applicable gift limit is one hundred dollars (\$100) per calendar year.

Fiscal Impact Statement: None submitted by the City Attorney. Neither the City Administrative Officer nor the Chief Legislative Analyst has completed a financial analysis of this report.

Community Impact Statement: None submitted.

Summary:

At its special meeting of December 6, 2013, the Rules, Elections and Intergovernmental Relations Committee considered a City Attorney report and draft Ordinance relative to changes to the City's Governmental Ethics Ordinance. After consideration and providing an opportunity for public comment, the Committee recommended that Council adopt the draft Ordinance dated December 3, 2013 with one amendment to Sec 49.5.8 (c) (4) b: For all other restricted sources, the applicable gift limit is one hundred dollars (\$100) per calendar year. This matter is now submitted to Council for its consideration.
