MOTION

I HEREBY MOVE that the Council ADOPT the following recommendations of the City Attorney in order to effect settlement in the case entitled William Ramsey, et al. v. City of Los Angeles, United States District Court Case No. CV10-05592CBM(SHX). (This case arises out of allegations by 28 Los Angeles Fire Department dual function firefighter/paramedics that the City violated the Fair Labor Standards Act by failing to pay them overtime after 40 hours in a week), SUBJECT TO THE APPROVAL OF THE MAYOR:

1. AUTHORIZE the City Attorney to pay a total of \$220,096 in settlement of the above-entitled matter; \$105,000 from City Attorney Fund 100, Department 59, Account No. 009770 and the remainder from Fire Department Fund 100, Department 38, Account No. 001012.
2. AUTHORIZE the City Attorney to draw a demand for \$105,000 in attorney's fees on City Attorney Fund 100, Department 59, Account No. 009770 and made payable to the Law Firm of Deason & Archbold.
3. AUTHORIZE the City Attorney to draw the remainder of the settlement demand on Fire Department Fund 100, Department 38, Account No. 001012 and made payable as follows:
