TRANSPORTATION COMMITTEE REPORT relative to installing rectangular rapid flash beacons and a crosswalk at Abbot Kinney Boulevard and Boccaccio Avenue/Marr Street.

Recommendation for Council action, as initiated by Motion (Bonin – Fuentes):

INSTRUCT the Los Angeles Department of Transportation (LADOT) to install rectangular rapid flash beacons and a crosswalk at Abbot Kinney Boulevard and Boccaccio Avenue/Marr Street.

Fiscal Impact Statement: None submitted. Neither the City Administrative Officer nor the Chief Legislative Analyst has completed a financial analysis of this report.

Community Impact Statement: None submitted.


SUMMARY

At its meeting held September 25, 2013, Council considered Motion relative to installing rectangular rapid flash beacons and a crosswalk at Abbot Kinney Boulevard and Boccaccio Avenue/Marr Street. Motion states that area residents want a crosswalk for people to safely cross Abbot Kinney Boulevard. There are no intersections nearby and pedestrians must either walk a great distance out of their way or jaywalk to cross the street. Motion movers state that LADOT is conducting a pilot using rectangular rapid flash beacons to enhance pedestrian safety at intersections throughout the City. The beacons are flashing lights that supplement warning signs at unsignalized intersections or mid-block crosswalks. These new devices have shown a high rate of motorist compliance when coupled with the installation of a crosswalk. Motion movers recommend that Council instruct LADOT to install these beacons and a crosswalk at Abbot Kinney Boulevard and Boccaccio Avenue/Marr Street. Council referred Motion to the Transportation Committee for consideration.

At its special meeting held December 4, 2013, the Transportation Committee recommended that Council approve Motion.
