**MOTION**

I HEREBY MOVE that the Council ADOPT the following recommendations of the City Attorney in order to effect settlement in the case entitled Vivian Snyder v. City of Los Angeles, Los Angeles Superior Court Case No. NC044442. (This matter involves plaintiff Vivian Snyder, who was injured while walking on the sidewalk in San Pedro when she tripped on a City installed coping wall at 1210 West O'Farrell Street in San Pedro), **SUBJECT TO THE APPROVAL OF THE MAYOR:**

1. AUTHORIZE the City Attorney to pay a total of \$140,000 in settlement of the above-entitled matter from the City Attorney, Fund No. 100, Department 59, Account 009770.
2. AUTHORIZE the City Attorney to draw a demand thereon in said amount and made payable to The Law Office of Richard S. Stout and Vivian Snyder.
3. AUTHORIZE the City Attorney, or designee, to prepare Controller instructions for any necessary technical adjustments, subject to the approval of the City Administrative Officer, and AUTHORIZE the Controller to implement the instructions.

This matter was approved by the Budget and Finance Committee (Krekorian – Englander – Koretz "yes") at its meeting on October 28, 2013, in Closed Session as permitted by Government Code Section 54956.9(d)(1).
