I HEREBY MOVE that Council ADOPT the following recommendations relative to a recent California Public Utilities Commission (CPUC) decision regarding the regulation of ridesharing services (Item No. 33, Council file No. 13-1353), SUBJECT TO THE CONCURRENCE OF THE MAYOR:
