I HEREBY MOVE that the Council ADOPT the following recommendations of the City Attorney in order to effect settlement in the case entitled Louie Rosales, et al. v. City of Los Angeles, United States District Court Case No. CV12-00034 DDP (MANx). (This matter arises from an incident involving members of the Los Angeles Police Department that occurred on February 4, 2011), **SUBJECT TO THE APPROVAL OF THE MAYOR:**

1. AUTHORIZE the City Attorney to pay a total of \$975,000 in settlement of the above-entitled matter from the City Attorney, Fund No. 100, Department 59, Account 009770.
2. AUTHORIZE the City Attorney to draw a demand thereon in said amount and made payable to The Layfied Lawfirm, APC and Louie Rosales and Jessica Rosales.
3. AUTHORIZE the City Attorney, or designee, to prepare Controller instructions for any necessary technical adjustments, subject to the approval of the City Administrative Officer, and AUTHORIZE the Controller to implement the instructions.
