



Sufficient funds are available in the CD-4 portion of the Council District AB 1290 Fund for this purpose.

I THEREFORE MOVE that \$100,000 in the AB1290 Fund No. 53P, Account No. 281204 (CD 4 Redevelopment Projects - Services) be transferred / appropriated to the Zoo Enterprise Trust Fund No. 40E-87, Revenue Source Code 451301 (Transfers and Grants) and be further appropriated therefrom to the Zoo Enterprise Trust Fund 40E-87, Account No. 878350 for a program of holiday lights at the Los Angeles Zoo.

I FURTHER MOVE that the Zoo Department be directed / authorized to make payment to the Greater Los Angeles Zoo Association (GLAZA) in the above amount from the above source and for the above purpose and to prepare, process and execute any other documents as may be needed for this purpose.

I FURTHER MOVE that the Zoo Department be authorized to make any technical corrections or clarifications to the above instructions in order to effectuate the intent of this Motion.
