PUBLIC WORKS AND GANG REDUCTION COMMITTEE REPORT relative to reinstating the streets and roadways withdrawn from public use in 1936 under Ordinance No. 76896 within Council District 3 as public streets.

Recommendation for Council action, pursuant to Motion (Blumenfield - Martinez):

INSTRUCT the City Administrative Officer (CAO), with the assistance of the Bureau of Engineering (BOE), to report on the funding and staffing resources necessary to allow BOE to investigate the condition of the streets and roadways withdrawn from public use under Ordinance No. 76896 within Council District 3.

Fiscal Impact Statement: Neither the CAO nor the Chief Legislative Analyst has completed a financial analysis of this report.


Community Impact Statement: None submitted.

SUMMARY

At a regular meeting held on September 17, 2014, the Public Works and Gang Reduction Committee considered a Motion (Blumenfield - Martinez) relative to reinstating the streets and roadways withdrawn from public use in 1936 under Ordinance No. 76896 within Council District 3 as public streets. BOE staff responded to the request and stated that additional resources would need to be allocated to the bureau to be able to address the request. The Committee Chair proposed a modified request for this matter to instruct the CAO, with the assistance of the BOE, to report on the funding and staffing resources necessary to allow BOE to investigate the condition of the streets and roadways withdrawn from public use under Ordinance No. 76896 within Council District 3. An opportunity for public comment was held. After further discussion of the matter, the Committee moved to approve the recommendation presented by the Committee Chair as detailed above. This matter is now forwarded to the Council for its consideration.
