CATEGORICAL EXEMPTION, PUBLIC WORKS AND GANG REDUCTION COMMITTEE REPORT and ORDINANCE relative to the private driveway name establishment request for Super King Way to be located at Sherman Way at Sherman Circle.

Recommendations for Council action, SUBJECT TO THE APPROVAL OF THE MAYOR:

1. FIND that the private driveway name establishment request for Super King Way to be located at Sherman Way at Sherman Circle is exempt from the California Environmental Quality Act (CEQA) of 1970, pursuant to the categorical exemptions in the City of Los Angeles Environmental Guidelines under Article III, Class 5(4).
2. PRESENT and ADOPT the accompanying ORDINANCE to change the name of the private driveway on Sherman Way at Sherman Circle from Albertsons Way and established as Super King Way.

Fiscal Impact Statement: The City Engineer reports that a fee of \$4,494 was paid for processing this request pursuant to Section 18.09 of the Municipal Code.

Community Impact Statement: None submitted.

SUMMARY

On May 7, 2014, your Public Works and Gang Reduction Committee considered a November 27, 2013 City Engineer report relative to the private driveway name-establishment request for Super King Way to be located at Sherman Way at Sherman Circle. This item was originally approved by Council on March 19, 2014. It was determined that the item would need to be considered by Council a second time to include language in the recommendations to ensure the complete processing of the attached Ordinance. After consideration and having provided an opportunity for public comment, the Committee moved to recommend approval of this item. This matter is now submitted to Council for its consideration.
