

ORDINANCE NO. 183085

An Ordinance of the City of Los Angeles changing the name of that certain private driveway lying on Sherman Way at Sherman Circle as Super King Way (Private Driveway). THE PEOPLE OF THE CITY OF LOS ANGELES DO ORDAIN AS FOLLOWS:

Section 1. The City Council of the City of Los Angeles finds that the public interest, convenience and necessity require that the name of that certain private driveway, 40 feet wide, hereinafter described, lying on the north side of Sherman Way at Sherman Circle which, or any portion of which may be or may have been named or known as or called Albertsons Way be and the same is hereby changed as Super King Way (Private Driveway).

Those portions of Lots 537, Tract No. 1000, as per map recorded in Book 19, pages 1 to 34, inclusive, of Maps, and Lot A, of the Los Angeles Farming and Milling Company, attached to deed recorded in Book 4232, page 118, of Deeds, both in the office of the County Recorder of Los Angeles County, included within a strip of land 40.00 feet wide lying 20 feet on each side of the centerline described as follows:

Beginning at the intersection of a line parallel with and distant 55 feet easterly measured at right angles from the easterly line of Lot 2, Tract No. 22874, as per map recorded in Book 616, pages 43 and 44, of Maps, in the office of said County Recorder, with the northerly line of Sherman Way as established by Easement Deed recorded April 10, 1970 in Book D4682, page 237, of Official Records, in the office of said County Recorder; thence northerly along said parallel line 40.00 feet.

The sidelines of said strip of land are to be prolonged or shortened so as to terminate northerly in a line parallel with and distant 40.00 feet northerly measured at right angles from said northerly line of Sherman Way and southerly in said northerly line of said Sherman Way.

Sec. 2. The naming of the private driveway herein does not construe it to be either public street or approved private street and is for identification only.

Sec. 3. Pursuant to the provisions of Section 252 of the Charter of the City of Los Angeles, this Ordinance shall become effective upon publication.

Sec. 4. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.

DECLARATION OF POSTING ORDINANCE
