The Council District 13 Public Benefit Trust Fund proves funds for the support of police and all other public benefit and community activities within Council District 13.

Action is needed, at the request of the Greater Echo Park Elysian Neighborhood Council, to provide the Department of Recreation and Parks funds for programming, general beautification, and plant improvement at the Lake Street Recreation Center and Echo Park Recreation Center.

Sufficient funds are available within the CD-13 Public Benefit Trust Fund which could be transferred to the Department of Recreation and Parks for these purposes.

I THEREFORE MOVE that \$1,600 within the CD-13 Public Benefit Trust Fund No. 904 be transferred/appropriated to a new account in Recreation and Parks Account Fund No. 301, Department 88, entitled "Lake Street Recreation Center" to be used to provide the Department of Recreation and Parks funds for programming, general beautification, and plant improvement at the Lake Street Recreation Center.

I FURTHER MOVE that \$4,000 within the CD-13 Public Benefit Trust Fund No. 904 be transferred/appropriated to a new account in Recreation and Park Account Fund No. 301, Department 88, entitled "Echo Park Recreation Center" to be used to provide the Department of Recreation and Parks funds for programming, general beautification, and plant improvement at the Echo Park Recreation Center.

I FURTHER MOVE that the Department of Recreation and Parks be authorized to make any technical corrections or clarifications to the above instructions in order to effectuate the intent of this Motion; and authorize the Controller to implement these instructions.
