Community Impact Statement: None submitted.


SUMMARY

At its special meeting of December 6, 2013, the Rules, Elections and Intergovernmental Relations Committee considered a City Ethics Commission (CEC) report relative to proposed amendments to the conflict of interests code for the Los Angeles Convention Center (LACC). The CEC reports that the LACC's staffing structure will change on December 8, 2013 and its conflict of interests code has been updated to accurately reflect the new structure. The CEC report, attached to the Council file, describes the revisions in detail.

After consideration and having provided an opportunity for public comment, the Committee recommended that Council adopt the proposed amendments to Schedules A and B of the conflict of interests code for the LACC to accurately reflect the Department's staffing structure. This matter is now forwarded to the Council for consideration.


