I HEREBY MOVE that the Council ADOPT the following recommendations of the City Attorney in order to effect settlement in the case entitled Tammy Kim v. City of Los Angeles, et al., United States District Court Case No. CV13-01196 RGK. (This matter arises from incidents involving members of the Los Angeles Police Department that occurred between August 2009 and April 2011), **SUBJECT TO THE APPROVAL OF THE MAYOR:**

1. AUTHORIZE the City Attorney to pay a total of \$575,000 in settlement of the above-entitled matter from the City Attorney, Fund No. 100, Department 59, Account 009770.
2. AUTHORIZE the City Attorney to draw a demand thereon in said amount and made payable to Robert Mann and Donald W. Cook, Attorneys at Law and Tammy Kim.
3. AUTHORIZE the City Attorney, or designee, to prepare Controller instructions for any necessary technical adjustments, subject to the approval of the City Administrative Officer, and AUTHORIZE the Controller to implement the instructions.
