COMMUNICATION FROM CHAIR AND MEMBER, HOUSING COMMITTEE relative to educating and informing residents regarding California's Paid Family Leave Program.

Recommendations for Council action, pursuant to Motion (Martinez - O'Farrell):

- 1. INSTRUCT the Department of General Services, Los Angeles Public Library, Department of Recreation and Parks, Los Angeles Housing and Community Investment Department, and other departments as appropriate, to coordinate with the Commission on the Status of Women to identify appropriate city facilities and post relevant information throughout the city to educate and inform residents about California's Paid Family Leave program.
- 2. REQUEST the Commission on the Status of Women to develop a coordinated public awareness campaign to increase awareness among our city's residents of the California Paid Family Leave program.
