Summary:

At a meeting held on January 13, 2015 (continued from December 16, 2014), the Planning and Land Use Management Committee considered the inclusion of the John L. Matheson / Church of Latter Day Saints California Mission Residence located at 2067 South Hobart Boulevard in the list of Historic-Cultural Monuments. Staff from DCP gave the Committee background information on this matter. The property owner and representative, members of the public and Council District 10 staff also spoke. While the DCP, Office of Historic Resources recommended approval of the proposed designation, the proposed designation is deemed denied by the Cultural Heritage Commission due to its failure to act by October 20, 2014.


