PERSONNEL AND ANIMAL WELFARE COMMITTEE and ORDINANCE FIRST CONSIDERATION relative to amending the Los Angeles Administrative Code (LAAC) to add a new Section 4.310.1 to provide administrative guidelines and a waiver provision for the Dependent Eligibility Verification (DEV) Program administered by the Personnel Department.

Recommendation for Council action, SUBJECT TO THE APPROVAL OF THE MAYOR:

PRESENT and ADOPT the accompanying ORDINANCE amending Article 5 of Chapter 7 of the LAAC pertaining to the administration of employee benefits programs by adding a new Section 4.310.1 to provide administrative guidelines and a waiver provision for the DEV Program administered by the Personnel Department.

Summary:

On May 20, 2014, your Committee considered an April 1, 2014 City Attorney report and Ordinance relative to amending the LAAC to add a new Section 4.310.1 to provide administrative guidelines and a waiver provision for the DEV Program administered by the Personnel Department.
