

ORDINANCE NO. 185609

An ordinance amending Rules and Regulations for Cannabis Procedures, Ordinance No. 185344, established in support of Article 4 of Chapter X of the Los Angeles Municipal Code to regulate commercial cannabis activities in the City of Los Angeles.

**THE PEOPLE OF THE STATE OF CALIFORNIA
DO ORDAIN AS FOLLOWS:**

Section 1. Paragraph 11 of Section A of Regulation No. 10 of Ordinance No. 185344 is amended to read as follows:

11. A Licensee is not required to have his or her cannabis goods tested or to follow the labeling provisions as required by the State of California or DCR until 120 days after City licensure, or until required under State of California Code of Regulations, Title 16, Division 42, Chapter 5, Section 5715, whichever is sooner, after which all cannabis goods shall be labeled and tested. (Violation Type – Serious)

Sec. 2. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.


