Council Action

The City Council ADOPTED the following recommendation(s), relative to levying the Little Tokyo Business Improvement District ("District") special assessment for the District's eleventh fiscal year (operating year) beginning on January 1, 2014 through December 31, 2014, SUBJECT TO THE APPROVAL OF THE MAYOR:

1. HEAR PROTESTS against the proposed levying of the special assessment for the District's 2014 fiscal year, pursuant to Section 36524 of the California Streets and Highways Code.
2. PRESENT and ADOPT the accompanying ORDINANCE levying the special assessment for the District's 2014 fiscal year, if a majority protest, as defined by Section 36525 of the California Streets and Highways Code is found not to exist.
3. APPROVE the Little Tokyo Business Improvement District Advisory Board for the District's 2014 fiscal year.
4. AUTHORIZE the City Clerk, subject to City Attorney approval, to prepare, execute and administer a contract between the City and the L'il Tokyo Businessmen's Association, the nonprofit service provider for administration of the District.
