The City Council ADOPTED the following recommendation(s), contained in COMMUNICATIONS FROM THE CITY ADMINISTRATIVE OFFICER (CAO) AND THE PERSONNEL DEPARTMENT which were WAIVED, pursuant to Council Rule 17, by the Chair of the Budget and Finance Committee, SUBJECT TO THE APPROVAL OF THE MAYOR:

1. AUTHORIZE the CAO to retain and enter into a legal services contract with the law firm of Walsh & Associates, APC, in the initial amount up to \$200,000 for advice and legal representation relating to the matter of Francine Godoy v. City of Los Angeles, et al., Los Angeles Superior Court Case No. BC524640, commencing from August 1, 2013, with the funds to be encumbered within the Attorney Conflicts Panel Fund No. 46T, Department 10.
2. AUTHORIZE the CAO to prepare Controller instructions for any technical adjustments and INSTRUCT the Controller to implement the instructions.
