PERSONNEL AND ANIMAL WELFARE COMMITTEE REPORT and ORDINANCE FIRST CONSIDERATION relative to amending the Los Angeles Municipal Code (LAMC) to rename Industrial Waste Inspector job classifications as Environmental Compliance Inspectors and to specify their authority.

Recommendation for Council action, SUBJECT TO THE APPROVAL OF THE MAYOR:

PRESENT and ADOPT the accompanying ORDINANCE amending Subsections (b) and (f) — (k) of Section 61.07 of Article 1 of Chapter VI, and Section 64.70.06 of Article 4.4 of Chapter VI of the LAMC to rename the Industrial Waste Inspector job classifications as Environmental Compliance Investigators and to specify their authority.

Fiscal Impact Statement: Neither the City Administrative Officer nor the Chief Legislative Analyst has completed a financial analysis of this report.

Community Impact Statement: None submitted.

Summary:

On August 5, 2014, your Committee considered a June 25, 2014 City Attorney report and Ordinance relative to amending LAMC Sections 61.07 and 64.70.06 to rename Industrial Waste Inspector job classifications as Environmental Compliance Inspectors and to specify their authority. According to the City Attorney, on May 28, 2014, Council requested the City Attorney prepare and present an Ordinance to amend Subsections (b) and (f) — (k) of Section 61.07 of Article 1 of Chapter VI, and Section 64.70.06 of Article 4.4 of Chapter VI of the LAMC to rename Industrial Waste Inspector job classifications as Environmental Compliance Investigators and to specify their authority as coextensive with Street Services officers.

During the meeting, representatives of the Bureau of Sanitation (BOS) and the City Attorney answered questions from the Committee members. During the course of the meeting, the BOS requested that the Ordinance be amended incorporate a number of technical changes.

After consideration and having provided an opportunity for public comment, the Committee moved to approve the Ordinance, as amended, to amend the LAMC to rename Industrial Waste Inspector job classifications as Environmental Compliance Inspectors and to specify their authority.
