I HEREBY MOVE that the Council ADOPT the following recommendations of the City Attorney in order to effect settlement in the case entitled Ronald Boone v. City of Los Angeles, United States District Court Case No. CV 10-00617; Ninth Circuit Case No. 11-56704. (This matter arises from an incident involving a deputy city attorney that occurred on various dates during a litigation in which the deputy was representing the City of Los Angeles and its individual police officers), **SUBJECT TO THE APPROVAL OF THE MAYOR:**

1. AUTHORIZE the City Attorney to pay a total of \$250,000 in settlement of the above-entitled matter from the City Attorney Fund No. 100, Department 59, Account 009770.
2. AUTHORIZE the City Attorney to draw a demand thereon in said amount and made payable to the Law Offices of Olu Orange and Ronald Boone and Sharon Mosby.
3. AUTHORIZE the City Attorney, or designee, to prepare Controller instructions for any necessary technical adjustments, subject to the approval of the City Administrative Officer, and AUTHORIZE the Controller to implement the instructions.
