I HEREBY MOVE that the Council ADOPT the following recommendations of the City Attorney in order to effect settlement in the case entitled Judy Nelson v. City of Los Angeles, Los Angeles Superior Court Case No. BC524419. (This matter arises from a trip and fall incident that occurred on the sidewalk adjacent to 543 Rose Avenue on February 27, 2013), **SUBJECT TO THE APPROVAL OF THE MAYOR:**

1. AUTHORIZE the City Attorney to pay a total of \$245,000 in settlement of the above-entitled matter from City Attorney, Fund 100, Department 59, Account 009770.
2. AUTHORIZE the City Attorney to draw demands thereon in the amount of \$245,000 and made payable to Tracy Baer, Esq., Weber & Baer and Judy Nelson.
3. AUTHORIZE the City Attorney, or designee, to prepare Controller instructions for any necessary technical adjustments, subject to the approval of the City Administrative Officer, and AUTHORIZE the Controller to implement the instructions.
