

TRANSPORTATION COMMITTEE REPORT relative to restricting the use of vehicles over 6,000 pounds on a segment of 135th Street.

Recommendation for Council action, as initiated by Motion (Buscaino – Bonin):

REQUEST the City Attorney, in conjunction with the Los Angeles Department of Transportation (LADOT), to prepare and present an ordinance amending Section 80.36.1(d) of the Los Angeles Municipal Code to restrict the use of vehicles over 6,000 pounds on 135th Street between Estrella and Vermont Avenues.

Fiscal Impact Statement: Neither the City Administrative Officer nor the Chief Legislative Analyst has completed a financial analysis of this report.

Community Impact Statement: None submitted.


SUMMARY

On June 25, 2014, Council considered Motion (Buscaino – Bonin) relative to restricting the use of vehicles over 6,000 pounds on a segment of 135th Street. Motion states that heavy truck traffic along 135th Street is causing serious problems for the surrounding community. Parents and faculty of 135th Street Elementary School are concerned about the dangers created by the increasing number of large trucks that travel in front of the school. Additionally, noise and vibration from these trucks are affecting the quality of life for the surrounding neighbors. LADOT has conducted a study that verifies a large volume of commercial truck traffic along 135th Street. Motion recommends that Council request the City Attorney to prepare an ordinance to restrict the use of vehicles over 6,000 pounds on 135th Street between the 1-110 Freeway and Vermont Avenue. Council referred Motion to the Transportation Committee for consideration.

At its meeting held September 10, 2014, the Transportation Committee recommended that Council approve Motion, as amended to replace the proposed I-110 Freeway boundary with Estrella Avenue.
