**MOTION**

I HEREBY MOVE that the Council ADOPT the following recommendations of the City Attorney in order to effect settlement in the case entitled Huntington-EI Sereno, LLC v. City of Los Angeles, Los Angeles Superior Court Case No. BC522010. (This matter involves damage to real property located at 4837 North Huntington Drive as a result of a blockage in a City storm drain on or about October 12, 2012), **SUBJECT TO THE APPROVAL OF THE MAYOR:**

1. APPROVE the proposed settlement for a total of \$143,140.74.
2. AUTHORIZE the City Attorney to execute a settlement agreement and all other documents necessary to implement the settlement.
3. AUTHORIZE the Chief Accounting Officer for the Department of Public Works to draw a demand warrant for \$143,140.74 from the Stormwater Pollution Abatement Fund, Fund Number 511, Department 50, Account No. 50LS59, titled "Liability Claims" payable to the Law Offices of Gittler & Bradford Client Trust Account upon the execution of a Settlement and Release Agreement by the parties.
4. AUTHORIZE the City Attorney, or designee, to prepare Controller instructions for any necessary technical adjustments, subject to approval of the City Administrative Officer, and AUTHORIZE the Controller to implement those instructions, if any.

This matter was recommended for approval by the Budget and Finance Committee (Krekorian - Englander – Koretz - Blumenfield - Bonin) at its meeting on August 25, 2014, in Closed Session as permitted by Government Code Section 54956.9(d)(1).
