Re: Adopted WRAC motion supporting CF 14-1057-S9

Dear City officials,

The Westside Regional Alliance of Councils (WRAC) is an alliance of fourteen Neighborhood and Community Councils on the Westside of Angeles, located in CDs 5 and 11 and portions of CDs 4 and 10.

In recent years, a complete abdication of responsibility for basic vehicle dwelling regulations has led to a proliferation of RVs and other vehicles permanently parked in areas that have existing parking restrictions. Past ordinances that had reasonable and legal restrictions on locations and times vehicles used for dwelling could park have been left to lapse and in doing so the situation on our residential streets, in our protected wetlands, and in other areas with existing parking restrictions has deteriorated and neither those living in vehicles nor those living, working and recreating in these same areas wins. It is long past time the City revisit basic ordinances that apply equitably to all citizens.

Therefore, the following position has been adopted by eight member councils and is therefore an official position of WRAC:

The Westside Regional Alliance of Councils supports CF 14-1057-S9 (Buscaino/Koretz) – Regulation of Vehicle Dwelling.

The language of the above motion has been approved by the following WRAC member Councils:, Brentwood Community Council, Mar Vista Community Council, Venice Neighborhood Council, Westwood Neighborhood Council, Del Rey Neighborhood Council, Pacific Palisades Community Council, Westside Neighborhood Council, & Westwood Community Council.

No member Councils have opposed this measure or submitted a minority letter to accompany this position.
