SUBJECT MATTER: AMENDING SUBSECTIONS A AND SUBDIVISION 3 OF SUBSECTION B OF SECTION 63.44 OF CHAPTER VI OF THE LOS ANGELES MUNICIPAL CODE TO PROHIBIT VENDING OF COMMERCIAL ITEMS OR SERVICES IN ALL PUBLIC PARKS(INCLUDING BEACH PARKS AND RECREATION AREAS), AND AMENDING SUBDIVISION 4 OF SUBSECTION D AND SUBDIVISION 9 OF SUBSECTION I OF SECTION 63.44 OF CHAPTER VI OF THE LOS ANGELES MUNICIPAL CODE TO FURTHER DEFINE AND PROHIBIT CAMPING, INCLUDING THE USE OF TENTS, WITHIN ALL CITY PARKS, EXCEPT IN LOCATIONS DESIGNATED FOR SUCH PURPOSES, ADDING A NEW SUBSECTION R TO SECTION 63.44 TO SPECIFY PENALTIES FOR VIOLATIONS, AND ADDING A NEW SUBSECTION S TO SECTION 63.44 TO ADD A SEVERABILITY CLAUSE TO ENSURE THAT IF A COURT DECLARES ANY PORTION OF THE SECTION TO BE UNLAWFUL THAT THE REMAINING PORTIONS OF SECTION 63.44 REMAIN IN FULL FORCE AND EFFECT
