

ECONOMIC DEVELOPMENT AND JOBS COMMITTEE REPORT relative to the Community Redevelopment Agency of Los Angeles (CRA/LA) Excess Bond Proceeds (EBP) Quarterly Project Status Report as of May 15, 2021.

Recommendation for Council action:

NOTE and FILE the June 2, 2021 CRA/LA Bond Oversight Committee report relative to CRA/LA EBP Quarterly Project Status Report as of May 15, 2021.

Summary:

On August 24, 2021, your Committee considered a June 2, 2021 CRA/LA Bond Oversight Committee report relative to the CRA/LA EBP Quarterly Project Status Report as of May 15, 2021. According to Bond Oversight Committee, on January 16, 2015, the City and CRA/LA entered into a Bond Expenditure Agreement (Council File No. 14-1174; Contract No. C-125212) for the purpose of transferring an initial \$84.1 million in EBP to the City as a result of the dissolution of the City's former redevelopment agency. Since the initial allocation, the City received an additional \$1.9 million in Fiscal Years (FY) 2017-18 and \$2.4 million in FY 2019- 20 for a total of approximately \$88.4 million in principle EBP funds. After the inclusion of \$6.3 million in interest earnings, the sum total of EBP proceeds as of May 15, 2021 is approximately \$95 million. After consideration and having provided an opportunity for public comment, the Committee moved to note and file the report. This matter is now submitted to Council for its consideration.
