Recommendation for Council action:

REFER the following recommendations from the Los Angeles 2020 Commission reports to the following Council committees:

- a. Recommendation regarding Elections Consolidation (holding municipal elections at the same time as state and federal elections) to be held in the Rules, Elections and Intergovernmental Relations Committee.
- b. Recommendation regarding Adopting a Truth in Budgeting Ordinance refer to the Budget and Finance Committee.
- c. Recommendation regarding Combining the Ports of Los Angeles and Long Beach refer to the Trade, Commerce and Tourism Committee.
- d. Recommendation regarding Establishing a Regional Tourism Authority dually refer to the Economic Development Committee and the Trade, Commerce and Tourism Committee.
- e. Recommendation regarding a Focus on Economic Clusters to Generate Jobs of the Future refer to the Economic Development Committee.
- f. Recommendation regarding Updating Community Plans refer to the Planning and Land Use Management Committee.

SUMMARY

At its special meeting of September 26, 2014, the Rules, Elections and Intergovernmental Relations Committee considered the Los Angeles 2020 Commission reports.
