Fiscal Impact Statement: None submitted by the EWDD. Neither the City Administrative Officer nor the Chief Legislative Analyst has completed a financial analysis of this report.

Community Impact Statement: None submitted.

On October 7, 2014, your Committee considered an August 27, 2014 EWDD report relative to the exemption for 24 positions pursuant to Charter Section 1001(d)(4). Specifically, one position is a Consolidated Plan position and 23 positions are Workforce Investment Act Annual Plan positions. According to the EWDD, on February 9, 2014, the Board of Civil Service Commissioners approved the civil service exemption of the above described positions and as such, these positions perform administrative and program duties, supporting the EWDD's Federal, State, and local grants.

After consideration and having provided an opportunity for public comment, the Committee moved to recommend approval to exempt 24 positions as described in the August 27, 2014 EWDD report and detailed in the above recommendation. This matter is now submitted to Council for its consideration.
