Mr. Williams,

We were at City Hall today to attend the Economic Development Committee meeting and make our comments for the record. We waited in a line of hundreds of people, but were unable to participate.

The following is our statement for the record:

The Midnight Mission has been providing a way to self-sufficiency for 100 years. A significant part of that is our job preparedness program; where we offer our program participants not only a framework for structure and accountability but provide for them a skillset for long-term employment as well as a head start in self-sufficiency. This often takes place in the form of entry level employment opportunities. As a nonprofit that relies on funding from donors and private contributions, the increase of the minimum wage would greatly reduce our ability to provide these vital program opportunities to our clients. Further, it would have negative impacts on our ability to provide the daily services so many of the most needy in our community depend on. The Midnight Mission stands opposed to an immediate increase of the minimum wage. And would ask that this committee take the time to fully investigate and understand the impacts on organizations in our line of work, and perhaps consider exemptions for agencies such as ours that are privately funded.
