#### SUMMARY

At its regular meeting held on February 26, 2018, the Budget and Finance Committee considered a City Attorney report dated January 12, 2018 relative to extending Contract No. C-125289 with the firm of Rose, Klein and Marias, LLP for an additional two years to February 15, 2020, for a total term of five years, on a contingency compensation basis only, for subrogation claims and litigation.

After providing an opportunity for public comment, the Committee recommended that Council approve the City Attorney recommendations as detailed above. This matter is now forwarded to the Council for its consideration.
