RE: FEES FOR ELECTION RECOUNTS

Honorable Members:

Los Angeles City Election Code Section 1400 (e) requires the City Clerk to recommend to the City Council, at least three months prior to each biennial Primary Nominating Election, the fees charged for a recount and the amount of the bond required of any registered voter demanding a recount. The City's next biennial Primary Nominating Election will be held on March 3, 2015. Voters may request the City Clerk perform a manual or electronic recount of any race.

Manual Recount

Based on the staffing requirements necessary to conduct the one percent manual tally in past elections, the City's manual recount fees would be \$9,246 per day plus \$0.17 for each ballot recounted manually. The daily rate includes costs for the setup, supervision of the tally and the executive recount board. The cost per ballot reflects staffing for tallying of ballots (computation details are shown in Attachment A).

Electronic Recount

Based on prior election tallies, the City's electronic recount fees would be \$1,999 for the cost of setup. In addition, a fee of \$0.14 will be charged for each ballot recounted electronically (computation details are shown in Attachment B).

We therefore recommend that the Council instruct the City Attorney, with the cooperation of the City Clerk, to prepare the necessary ordinance to provide the following election recount fee schedule:

1. Amend the manual recount fees for any municipal election conducted by the City of Los Angeles to be \$9,246 per day for each day that the recount is being conducted plus an additional \$0.17 per ballot for each ballot recounted manually.
2. Amend the electronic recount fees for any municipal election conducted by the City of Los Angeles to be \$1,999 plus an additional \$0.14 per ballot for each ballot recounted electronically.

Since bond requirements are calculated on the basis of the fees required and the number of ballots cast, the required bond amounts will change accordingly if the proposed fee schedule is approved.

The manual recount fees include:

1. A daily rate of \$9,245,53 for the setup, supervision of the recount and the recount board; plus
2. A per ballot cost of \$0.17 (\$851.34/5,000) for each ballot recounted manually.

Notes:

1. Each recount board consisting of 3 members can count approximately 5,000 ballots per day.
2. A maximum of 10 recount boards can be administered at any given time.

The electronic recount fees include:

1. A flat rate of \$1,999.20 for the setup; plus
2. A per ballot cost of \$0.14 (\$1,449.99/10,000) for each ballot recounted electronically.

Note: Each card reader can process approximately 10,000 ballots per hour.
