To the L.A. City Council:

HUFF (Homeless United for Friendship & Freedom) urges you to vote against the 5/C. File 14-1551 amending LAMC 63.44B re: park urfews. Please consider the absence of the required Coastal Development Permit first required in order to spare the City legal expense should it be challenged.

Please also vote not to create a new LAMC 56.11 (I believe the item is 6/C.File 14-1656, given the insufficient storage space for homeless possessions being abusively seized by police, again laying the City open to costly litigation.

I understand a large part of the nearly \$100 million on "homeless services and prevention" has gone to police activity—which is not only cruel and costly, but apparently unsuccessful even on its own terms.

I am also advised that these laws target black community members, given that 50% of the homeless population in town is black. Not to mention victims of domestic abuse and violence.

Affordable housing, supportive housing, the "Housing First" intiatives, are all far better alternatives. In the meantime, homeless folks (for their benefit and for the benefit of the broader ommunity) need supportive housing for folks with disabilities, and more housing generally (perhaps my SRO's?) for low-income people and displaced urban workers.

We urge you to vote for the smarter more sensible and more compassionate solutions.
