ESTABLISHMENT OF TEMPORARY PREFERENTIAL PARKING DISTRICT NO. 156 FOR THE

**EDGEWATER TERRACE NEIGHBORHOOD OF SILVER LAKE** 

#### RECOMMENDATION

- FIND that the establishment of Temporary Preferential Parking District (PPD) No. 156, pursuant to Los Angeles Municipal Code (L.A.M.C.) Section 80.58.d, is exempt from the California Environmental Quality Act (CEQA) as a Class 1 Categorical Exemption, under Article III.1.a.3 of the 2002 Los Angeles City CEQA Guidelines.
- 2. FIND that an adverse parking impact on Deane Street from Glendale Boulevard to Edgewater Terrace, Edgewater Terrace from Silver Lake Boulevard to the dead end south of Deane Street (2 blocks); Silver Lake Boulevard from Glendale Boulevard to Armstrong Avenue (2 blocks) caused by the visitors to and employees of the businesses on Glendale Boulevard from which the residents deserve immediate relief.
- ADOPT the accompanying RESOLUTION establishing Temporary Preferential Parking District No. 156 pursuant to Section 80.58.d of the Los Angeles Municipal Code (LAMC). Temporary Preferential Parking District No. 156 will include both sides of the residential portions of the street segments listed in Recommendation No. 2, above.
- 4. AUTHORIZE use of "NO PARKING, 11 PM 6 AM; VEHICLES WITH DISTRICT NO. 156 PERMITS EXEMPT" as the parking restriction for use on the residential portions of all streets in Temporary Preferential Parking District No. 156.
- 5. INSTRUCT the Los Angeles Department of Transportation (LADOT) to initiate the necessary procedures for the preparation and sale of parking permits to residents within Temporary Preferential Parking District No. 156, as specified in Section 80.58 of the LAMC.
- 6. DIRECT the LADOT to post the authorized parking restrictions on both sides of the residential portions of Deane Street from Glendale Boulevard to Edgewater Terrace, Edgewater Terrace from Silver Lake Boulevard to the dead end south of Deane Street (2 blocks), except for areas where parking is currently prohibited at all times in the interest of traffic flow or public safety.
- 7. DIRECT the LADOT to post or remove the authorized parking restrictions on both sides of the residential portions of additional streets within this district upon receipt and verification of

petitions requesting the installation or removal of the approved parking restrictions on a street segment and containing signatures from residents that represent at least 67 percent of the dwelling units on the street segment, upon City Council action establishing the district.

# COORDINATION

On November 18, 2013, the Department received letters from Councilmember Mitch O'Farrell, CD 13, requesting the establishment of Temporary PPD No. 156 and asking that a "No Parking, 11 PM to 6 AM; District No. 156 Permits Exempt" parking restriction be authorized for posting in this district to address the non-resident late night visitors to the restaurants and bars on Glendale Boulevard. The Councilmember and his staff, in consultation with the LADOT, have concluded that a Temporary PPD is the best solution available at this time to provide immediate relief to the residents of Temporary PPD No. 156.
