TRANSPORTATION COMMITTEE REPORT relative to declaring that the Granada Hills Plaza Shopping Center parking lot is subject to enforcement by the City of Los Angeles for violations of the California Vehicle Code (CVC).

Recommendations for Council action, as initiated by Resolution (Englander – O'Farrell):

1. RESOLVE to find and declare that the Granada Hills Plaza Shopping Center parking lot, located at 16201 San Fernando Mission Boulevard, is subject to enforcement by the City of Los Angeles for violations of the following CVC sections listed in Section 21107.8: CVC Sections 22350 (basic speed law), 23103 (reckless driving), and 23109 (speed contests and exhibitions of speed).
2. RESOLVE, pursuant to subsection (b) of CVC 21107.8, that this action shall not apply until the owner of the shopping mall lot posts signs.

Fiscal Impact Statement: Neither the City Administrative Officer nor the Chief Legislative Analyst has completed a financial analysis of this report.

Community Impact Statement: None submitted.

#### SUMMARY

On December 12, 2014, Council considered Resolution (Englander – O'Farrell) declaring that the Granada Hills Plaza Shopping Center parking lot is subject to the enforcement by the City of Los Angeles for violations of the California Vehicle Code regarding vehicle speed, reckless driving, and speed contests and exhibitions of speed. Resolution states that the California Department of Motor Vehicles (DMV) will be opening a new facility at the Granada Hills Plaza Shopping Center. The DMV facility is considered a Driver License Processing Center and will be the only one for all of Los Angeles County. Due to the expected increase in vehicular and pedestrian traffic at the Granada Hills Plaza Shopping Center, the property management is requesting that the City be authorized to enforce traffic laws within its private parking lot. Council referred Resolution to the Transportation Committee for consideration.

At its meeting held January 28, 2015, the Transportation Committee recommended that Council approve Resolution, authorizing the City to enforce CVC vehicle speed laws at the Granada Hills Plaza Shopping Center parking lot.
