

MOTION

I HEREBY MOVE that the Council ADOPT the following recommendations of the City Attorney in order to effect settlement in the case entitled Theodosia Horace v. City of Los Angeles, Los Angeles Superior Court Case No. BC483096. (This matter involves a Los Angeles Fire Department traffic collision which occurred on July 15, 2011 at the intersection of Gramercy Place and Manchester Avenue), **SUBJECT TO THE APPROVAL OF THE MAYOR:**

1. AUTHORIZE the City Attorney to pay a total of \$200,000 in settlement of the above-entitled matter from the City Attorney, Fund No. 100, Department 59, Account 009770.
2. AUTHORIZE the City Attorney to draw a demand thereon in the amount of \$200,000 and made payable to Law Offices of Ivie, McNeill & Wyatt and Theodosia Horace.
3. AUTHORIZE the City Attorney, or designee, to prepare Controller instructions for any necessary technical adjustments, subject to the approval of the City Administrative Officer, and AUTHORIZE the Controller to implement the instructions.
