

ORDINANCE NO. 183516

An ordinance amending Section 80.81 of the Los Angeles Municipal Code to decrease the speed limit on Cahuenga Boulevard West between Highland Avenue and Oakcrest Drive in the City of Los Angeles from 40 miles per hour to 35 miles per hour.

**THE PEOPLE OF THE CITY OF LOS ANGELES
DO ORDAIN AS FOLLOWS:**

Section 1. Subdivision C of Subsection (3) of Section 80.81 of Chapter VIII of the Los Angeles Municipal Code is amended by deleting the following:

Cahuenga Boulevard West between Highland Avenue and Oakcrest Drive.


Sec. 2. Subdivision C of Subsection (2) of Section 80.81 of the Los Angeles Municipal Code is amended to add the following in alphabetical order:

Cahuenga Boulevard West between Highland Avenue and Oakcrest Drive.

Sec. 3 The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.


