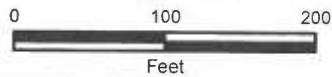


ORDINANCE NO. 183552

THE PEOPLE OF THE CITY OF LOS ANGELES DO ORDAIN AS FOLLOWS:

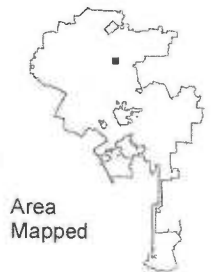

DECLARATION OF POSTING ORDINANCE
