An ordinance amending Ordinance No.182982 (2014-2016 Salaries and Benefits for Non-Represented Classes) to provide a salary for the new class of Controller Aide (Code 9199).

**THE PEOPLE OF THE CITY OF LOS ANGELES
DO ORDAIN AS FOLLOWS:**

Section 1. Section 1 of Ordinance 182982 is amended to add the following:

Sec. 2. Section 1 shall be operative upon publication pursuant to Charter Section 252(g).

Sec. 3. The City Administrative Officer and the Controller are authorized to correct any clerical errors or, if approved by the City Attorney, any technical errors in this Ordinance.

Sec. 4. The City Clerk shall certify to the passage of this ordinance and have it published in accordance with Council policy, either in a daily newspaper circulated in the City of Los Angeles or by posting for ten days in three public places in the City of Los Angeles: one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall; one copy on the bulletin board located at the Main Street entrance to the Los Angeles City Hall East; and one copy on the bulletin board located at the Temple Street entrance to the Los Angeles County Hall of Records.
