

TRANSPORTATION COMMITTEE REPORT and ORDINANCES FIRST CONSIDERATION relative to establishing the Office of Petroleum and Natural Gas Administration and Safety.

Recommendations for Council action, SUBJECT TO THE APPROVAL OF THE MAYOR:

1. PRESENT and ADOPT the accompanying ORDINANCE, dated May 24, 2017, to amend Los Angeles Administrative Code (LAAC) Sections 12.12(a), 13.18(B), 22.481(a)(4), 22.483(a)(6), 22.484(g)(2)(B), and 22.319 to transfer pipeline franchising responsibilities from the Los Angeles Department of Transportation (LADOT) to the Board of Public Works (BPW)(5 Ayes).
2. PRESENT and ADOPT the accompanying ORDINANCE, dated May 24, 2017, to amend Chapter 4 of Division 19 of the LAAC and Article 3 of Chapter I of the Los Angeles Municipal Code (LAMC) to transfer the Petroleum Administrator function from the City Administrative Officer (CAO) to the BPW (5 Ayes).
3. PRESENT and ADOPT the accompanying ORDINANCE, dated May 24, 2017, to amend LAAC Section 5.500 to expand the Council District Real Property Trust Funds to include all pipeline franchises (4 Ayes, 1 No).

Fiscal Impact Statement: Neither the City Administrative Officer nor the Chief Legislative Analyst has completed a financial analysis of this report.

Community Impact Statement: None submitted.

Summary:

On June 28, 2017, your Committee considered three City Attorney reports and accompanying Ordinances, all dated May 24, 2017 relative to: transferring pipeline franchising responsibilities from the LADOT to the BPW; transferring the Petroleum Administrator function from the CAO to the BPW; and expanding the Council District Real Property Trust Funds to include all pipeline franchises. On June 8, 2016, Council moved to request the City Attorney to prepare present an Ordinance(s) to amend Division 19, Chapter 4, of the LAAC, and any other applicable sections of the LAAC and LAMC, to transfer the Petroleum Administrator function and franchise duties from the LADOT to the BPW. Additionally, Council requested the BPW and instructed the LADOT, with assistance from the CAO, CLA, Department of City Planning, and Bureau of Engineering, to report within 90 days in connection with the formation of a Petroleum and Natural Gas Administration and Safety Office with the BPW to include reporting on potential changes to LAAC Section 5.500 to provide more options for the use of oil pipeline funds deposited into the Council District Real Property Trust Funds including funding for said Office.

After consideration and having provided an opportunity for public comment, the Committee, by unanimous vote, moved to recommend approval of the Ordinances as detailed above in

Recommendation Nos. 1 and 2. However, in regard to Recommendation No. 3, Councilmember Martinez voted No while the other Committee members voted Yes. This matter is now submitted to Council for its consideration.
