The Los Angeles Housing and Community Investment Department (HCID) is proud to be one of the leading agencies in offering vital services and resources to those most in need. In particular, HCID's FamilySource Centers (FSCs), located in the high need areas of the City, serve as one-stop community centers that provide a host of social, educational, financial, work, and family support services. In order to continue to provide these services to all residents of the City, HCID proposes to execute a sole-source contract with FennArc Studio Inc., a certified UDBE/CBE/WBE/MBE with 30 years of experience in the areas of code compliance reviews and accessibility evaluations/surveys, to conduct on-site evaluations and prepare construction-related accessibility compliance reports of the 19 FSC facilities listed below. The services provided by FennArc Studio will be funded through CDBG Fund 424/43, Account 43N605 – Building Improvement Fund from the 2016 Consolidated Plan.


