RE: Transmittal for Council File No. 15-0719-S26

On March 20, 2024, the Transportation Committee considered a City Attorney report and Ordinance relative to adding a new Chapter 19 to Division 19 of the Los Angeles Administrative Code (LAAC) implementing the Mobility Plan 2035 element of the City of Los Angeles General Plan; and Los Angeles Department of Transportation (LADOT) and Department of Public Works Bureau of Street Services (BSS) joint report relative to Mobility Plan 2035 Implementation and City Mobility Plan Street Improvement Measures; and LADOT, Department of City Planning (DCP), and Department of Public Works Bureau of Engineering (BOE) joint report relative to the Draft Mobility Plan 2035 Implementation Ordinance.

After an opportunity for public comment was provided, the committee recommended that Council approve the recommendations, as amended below:

1. RECEIVE and FILE the City Attorney's report and Ordinance dated August 7, 2023, attached to Council file No. 15-0719-S26.
2. REPLACE the Recommendations outlined in the LADOT and BSS joint report "Mobility Plan 2035 Implementation and City Mobility Plan Street Improvement Measures" dated January 10, 2024, attached to Council file No. 15-0719-S26, with the following recommendations:
 - a. INSTRUCT the LADOT and the Department of Public Works, with the assistance of the City Administrative Officer, to provide an annual report on the Interdepartmental Memorandum of Understanding (MOU) Oversight Committee, or any successor or replacement managing committee or working group, including an overview of signed project agreements.
 - b. INSTRUCT the LADOT and BSS to provide a work plan for projects on the Bicycle Enhanced Network (BEN) or Bike Lane Network (BLN) that can be completed by the end of Fiscal Year 2023-2024.
3. NOTE and FILE the LADOT, BOE and DCP joint report "Draft Mobility Plan 2035 Implementation Ordinance" dated January 17, 2024, attached to Council file No. 15-01719-S26.

4. NOTE and FILE the BSS letter dated January 17, 2024, attached to the Council file No. 15-0719-S26.
5. NOTE and FILE the LADOT report "Supplemental Report on Mobility Plan 2035 Implementation in Compliance with Measure HLA" dated March 14, 2024, attached to Council file No. 15-0719-S26.

Pursuant to the multiple referrals of this matter, the subject Council file is hereby transmitted to the Public Works Committee for further consideration.
