Subject: RESOLUTION NO. 21-9797 – PROPOSED SECOND AMENDMENT TO AGREEMENT NO. E6967 BETWEEN THE CITY OF LOS ANGELES HARBOR DEPARTMENT AND PIERPASS, LLC TO PROVIDE TRUCKING GATE MOVE DATA

Pursuant to Section 373 of the City Charter and Section 10.5(a) of the Los Angeles Administrative Code, enclosed for your approval is Resolution No. 21-9797 authorizing proposed Second Amendment Agreement No. 21-E6967-B between the City of Los Angeles Harbor Department (Harbor Department) and PierPass, LLC (PierPass); which was approved at the April 15, 2021 meeting of the Board of Harbor Commissioners. PierPass provides trucking gate move data collected from electronic gate management equipment at the seven major container terminals in order to support the Clean Truck Program (CTP) and the annual Port of Los Angeles (Port) emissions inventories. The proposed Second Amendment extends the term by one year and gives the Harbor Department the option to renew for an additional year. In accordance with the Shipping Act, this proposed Second Amendment will be filed with the Federal Maritime Commission (FMC). Annual compensation, pending approval of the proposed Second Amendment, will remain unchanged at \$48,000 and is the financial responsibility of the Harbor Department. The Harbor Department has received an Executive Directive-4 waiver. There is no impact to the General Fund.

RECOMMENDATION FOR CITY COUNCIL:

1. ADOPT the determination by the Board of Harbor Commissioners that the proposed action is administratively exempt from the requirements of the California Environmental Quality Act (CEQA) in accordance with Article II, Section 2(f) of the Los Angeles City CEQA Guidelines;
2. APPROVE Harbor Department Resolution No. 21-9797 authorizing proposed Second Amendment Agreement No. 21-E6967-B between the City of Los Angeles Harbor Department and PierPass, LLC; and
3. Return to the Board of Harbor Commissioners for further processing.
