

TRANSPORTATION COMMITTEE REPORT relative to the establishment of parking restrictions for oversized vehicles on certain streets in Council District Five.

Recommendations for Council action, pursuant to Resolution (Koretz - Bonin):

1. RESOLVE, pursuant to Los Angeles Municipal Code (LAMC) Section 80.69.4 and California Vehicle Code Section 22507, to hereby prohibit the parking of vehicles that are in excess of 22 feet in length or over seven feet in height, during the hours of 2:00 AM and 6:00 AM, along both sides of the following streets:
  - a. Pontius Avenue from Pico Boulevard to Santa Monica Boulevard
  - b. Cotner Avenue from Pico Boulevard to Santa Monica Boulevard
  - c. Nebraska Avenue from Cotner Avenue to Sepulveda Boulevard
  - d. Missouri Avenue from Cotner Avenue to Sepulveda Boulevard
  - e. La Grange Avenue from Cotner Avenue to Sepulveda Boulevard
  - f. Mississippi Avenue from Cotner Avenue to Sepulveda Boulevard
  - g. Tennessee Avenue from Cotner Avenue to Sepulveda Boulevard
2. DIRECT the Los Angeles Department of Transportation (LADOT), upon approval of this action, to post signs giving notice of a Tow Away, No Parking restriction for oversized vehicles on the streets listed above in Recommendation No. 1.
3. DIRECT the LADOT, upon the adoption of this Resolution, to initiate the necessary procedures for the preparation and sale of overnight parking permits, as specified in LAMC Section 80.69.4(c).
4. AUTHORIZE the LADOT to make any technical corrections or clarifications to the above instructions in order to effectuate the intent of this action.

Fiscal Impact Statement: None submitted by the LADOT. Neither the City Administrative Officer nor the Chief Legislative Analyst has completed a financial analysis of this report.

Community Impact Statement: None submitted.

Summary:

On September 9, 2015, your Committee considered a Resolution (Koretz - Bonin) relative to the establishment of certain oversized vehicle restricted streets in Council District Five pursuant to LAMC Section 80.69.4 and California Vehicle Code Section 22507. Specifically, the parking of vehicles that are in excess of 22 feet in length or over seven feet in height, during the hours of 2:00 AM and 6:00 AM, would be prohibited for both sides of the following streets:

- a. Pontius Avenue from Pico Boulevard to Santa Monica Boulevard
- b. Cotner Avenue from Pico Boulevard to Santa Monica Boulevard
- c. Nebraska Avenue from Cotner Avenue to Sepulveda Boulevard
- d. Missouri Avenue from Cotner Avenue to Sepulveda Boulevard
- e. La Grange Avenue from Cotner Avenue to Sepulveda Boulevard
- f. Mississippi Avenue from Cotner Avenue to Sepulveda Boulevard
- g. Tennessee Avenue from Cotner Avenue to Sepulveda Boulevard

Representatives from the Los Angeles Department of Transportation gave an overview of the proposed action and responded to questions from the Committee members. After consideration and having provided an opportunity for public comment, the Committee moved to recommend approval of the Resolution as detailed in the above recommendations. This matter is now submitted to Council for its consideration.
