Subject: RESOLUTION NO. 22-10036 – APPROVE SECOND AMENDMENT TO PERMIT NO. 896 WITH CRAFTED AT THE PORT OF LOS ANGELES

Pursuant to Section 606 of the City Charter, enclosed for your approval is Resolution No. 22-10036 authorizing approval of the Second Amendment to Permit No. 896 with Crafted at the Port of Los Angeles, a visitor-serving arts and crafts public marketplace and tourist attraction. Permit No. 896 has a 25-year term that commenced December 16, 2011, with two five-year options to extend. The proposed Second Amendment would amend the Fourth Compensation Period within Permit No. 896. Currently, the Fourth Compensation Period occurs over a five-year term from September 1, 2020 through and including August 31, 2025, and the Fifth Compensation Period begins on September 1, 2025. If approved, the Second Amendment would extend the term from five years to eight years and bifurcate the Fourth Compensation Period into two periods. Period 1 would run from September 1, 2020 through August 31, 2023, and Period 2 would run from September 1, 2023 through August 31, 2028. The subsequent Fifth Compensation Period would then begin on September 1, 2028. The proposed Second Amendment will neither change the original 25-year term of Permit No. 896, nor will it change the terms associated with the two five-year options to extend. There is no impact to the General Fund.

RECOMMENDATION FOR CITY COUNCIL:

- 1. ADOPT the determination by the Board of Harbor Commissioners that the proposed action is administratively and categorically exempt from the requirements of the California Environmental Quality Act (CEQA) under Article II, Section 2(f) and Article III, Class 1(14) of the Los Angeles City CEQA Guidelines; and
2. APPROVE POLA Resolution No. 22-10036 authorizing proposed approval of the Second Amendment to Permit No. 896 with Crafted at the Port of Los Angeles.
