DISCUSSION

The donation is for the benefit of Northeast Area and the community it serves. A Memorial Badge Display honoring Northeast Officers who were killed in the line of duty will be unveiled at the Northeast Community Police Station on June 8, 2016. Also being unveiled is a Little Library which will house books for children to read or take with them after visiting the police station. The Chief of Police, Staff Officers, surviving family members of officers being honored, City officials, and members of the community will be in attendance. Police Administrator Thom Brennan, Facilities Management Division, has given his approval for these additions to the Northeast Community Police Station lobby.

No expressed or implied commitments or promises were made to the donor or representatives of the donor. The donor will not receive any preferential treatment, endorsement, or recommendation; and the donor is not allowed the use of any Los Angeles Police Department (Department) patents.
