Recommendations for Council action:

2. INSTRUCT the LAPD that any modifications to the sUAS Deployment Policy needs to be presented to the Board of Police Commissioners, the Public Safety Committee and the City Council.



Summary:

At a special meeting held on February 7, 2018, the Public Safety Committee considered a Board of Police Commissioners report regarding a donation of sUAS for the benefit of the LAPD. Deputy Chief Girmala provided the Committee information pertaining to the sUAS Deployment Policy and the uses for the sUAS. After an opportunity for public comment, the Committee recommended to approve the donation as amended to include that any modifications to the policy would need to be presented to the Board of Police Commissioners, the Public Safety Committee and the City Council. This matter is now submitted to the Council for consideration.
