PUBLIC SAFETY COMMITTEE REPORT relative to a monetary donation for the benefit of the Metropolitan Division Mounted Platoon.

Recommendation for Council action:

ACCEPT the donation of \$32,000 from the Ahmanson Foundation for the benefit of the Metropolitan Division Mounted Platoon; and, THANK the donor for this generous donation.

Fiscal Impact Statement: None submitted by the Board of Police Commissioners. Neither the City Administrative Officer nor the Chief Legislative Analyst has completed a financial analysis of this report.

Community Impact Statement: None submitted.

SUMMARY

In a report to the Board dated March 16, 2018, attached to the Council file, the LAPD recommends that the Board approve the monetary donation from the Ahmanson Foundation for the benefit of the Metropolitan Division Mounted Platoon. The LAPD reports that the funds will be used to pay for the painting of all the buildings at the Ahmanson Equestrian Center. Any remaining funds will go towards future painting needs. Police Administrator Thom Brennan, Facilities Management Division, has approved the painting upon approval of this donation. No expressed or implied commitments or promises were made to the donor or representatives of the donor. The donor will not receive any preferential treatment, endorsement, or recommendation; and the donor is not allowed the use of any Los Angeles Police Department patents. At the meeting held on April 25, 2018, your Public Safety Committee considered this matter. After an opportunity for public comment was held, the Committee recommended that Council approve the monetary donation for the benefit of the Metropolitan Division Mounted Platoon, as recommended by the Board, as detailed above. This matter is now forwarded to the Council for its consideration.
