PUBLIC SAFETY COMMITTEE REPORT relative to the donation of a Police Service Dog (PSD) memorial statue for the benefit of the Metropolitan Division's K9 Platoon.

Recommendation for Council action:

ACCEPT the donation of a PSD memorial statue, valued at \$63,500, from the Los Angeles Police Foundation for the benefit of the Metropolitan Division's K9 Platoon; and, THANK the donor for this generous donation.

Fiscal Impact Statement: None submitted by the Board of Police Commissioners (Board). Neither the City Administrative Officer nor the Chief Legislative Analyst has completed a financial analysis of this report.

Community Impact Statement: None submitted.

SUMMARY

In a report to the Board dated May 18, 2018, attached to the Council file, the LAPD recommends that the Board approve the donation of a PSD memorial statue from the Los Angeles Police Foundation for the benefit of the Metropolitan Division's K9 Platoon. The LAPD reports that this donation is for the benefit of Metropolitan Division's K9 Platoon and will used to honor those PSDs that have been killed in the line of duty. Metropolitan Division has a restricted account with the Los Angeles Police Foundation. The Foundation will use funds from this account to pay for the statue. Metropolitan Division will provide maintenance and care for the memorial. At the meeting held on June 13, 2018, your Public Safety Committee considered this matter. After an opportunity for public comment was held, the Committee recommended that Council approve the donation of a PSD memorial statue for the benefit of the Metropolitan Division's K9 Platoon, as recommended by the Board, as detailed above. This matter is now forwarded to the Council for its consideration.
