On Thursday, August 1, 2019 (NANDC) e Empowerment Congress North Area Neighborhood Development Council held our General Board Meeting. Agenda item VI(n) called for us to weigh in on CF 16-0243. With a vote of 11-0-0 the following Community Impact Statement was approved:

The Empowerment Congress North Area Neighborhood Development Council calls on Los Angeles Mayor Eric Garcetti, the Los Angeles City Council, and the Los Angeles Department of Water and Power (LADWP) to:

1. Create and study multiple 100% real, clean energy by 2030 scenarios that excludes methane, biomass, biogas, nuclear energy, and unbundled renewable energy credits;
2. Select and implement a viable 100% real, clean energy scenario by the year 2025;
3. Provide job training in the renewable energy sector, and priority employment, for those who will be displaced by the transition from fossil fuel usage; and,
4. Include consumers and Neighborhood Council members on any advisory board, or in any focus group, involved in the selection of the 100% real, clean energy scenario.

NANDC applauds Mayor Eric Garcetti, the Department of Water and Power and the Los Angeles City Council for embarking on this ambitious, but critical, initiative to reduce our carbon footprint while also reducing the cost of energy for consumers. We look forward to progress reports and the successful completion of this endeavor.
